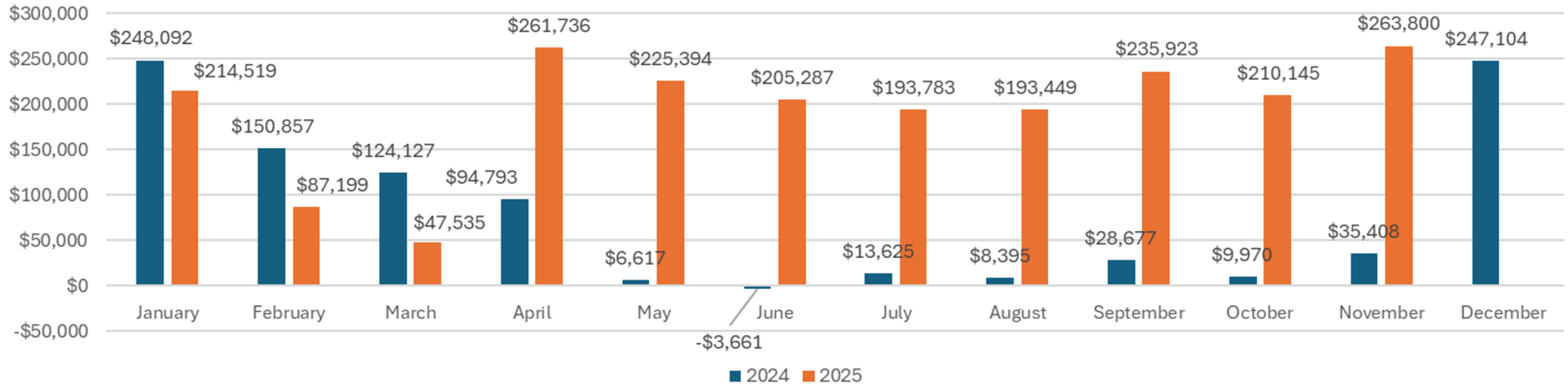

- d. 2026 Apportionments Held as Reserve until EOY

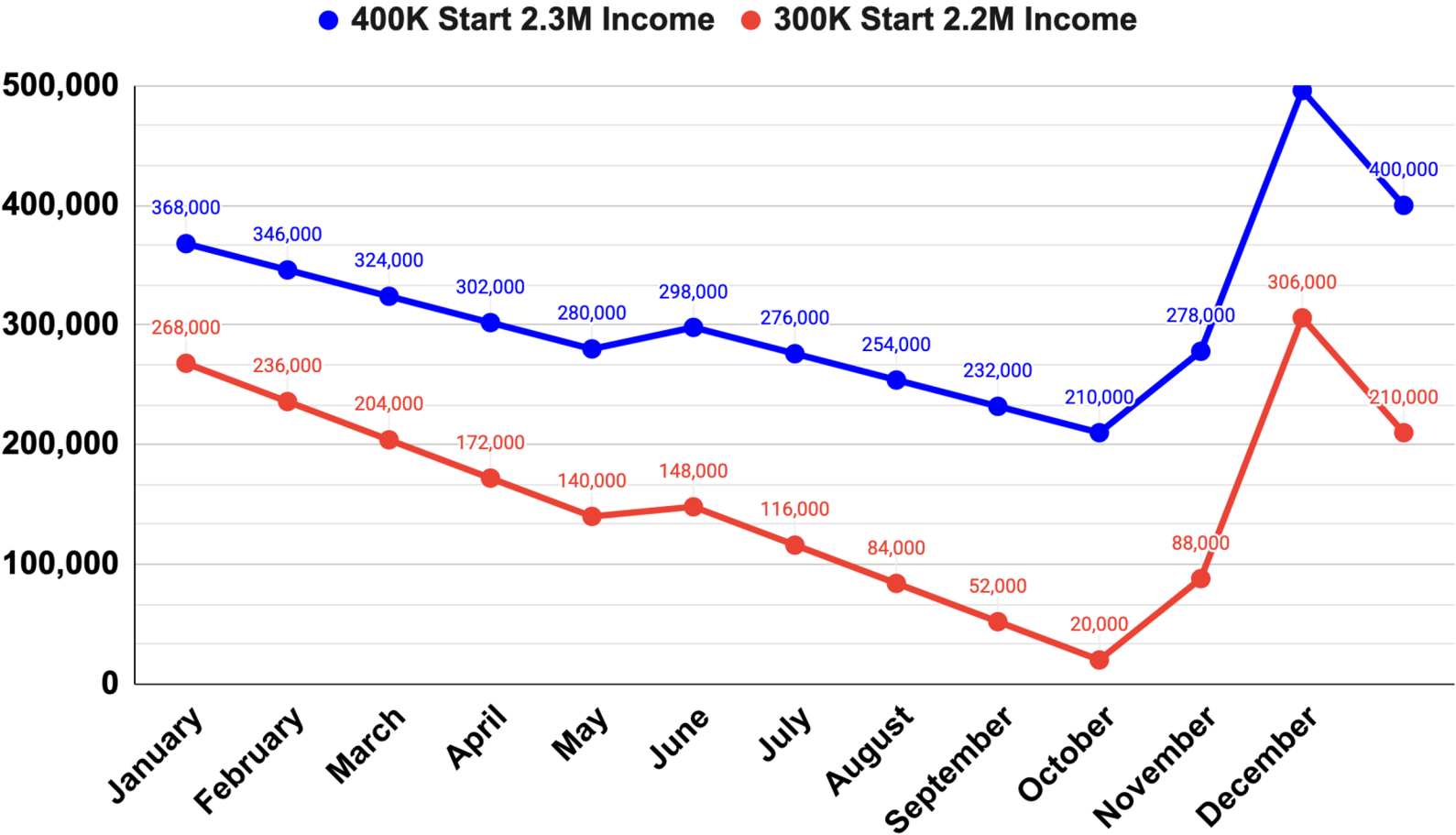
2024 and 2025 End of Month Bank Balance
